The 2025 Extension Competition for Graduate Students

AAEA Denver, CO July 27-29

The AAEA Extension Competition for Graduate Students provides an opportunity to develop and/or get feedback on programs that communicate research and practical information to Extension (usually non-economist) audiences. Entries can be based upon graduate student research for a thesis, dissertation or other academic work. The competition is sponsored by the Extension and Graduate Student Sections.

Who's Eligible?

Graduate students currently engaged in topics related to agricultural economics, agribusiness, natural resources, and/or community economic development, as well as those who graduated from such programs in Spring 2025 or later.

Participants must identify and work with a mentor with experience in outreach or extension activities.

The Application:

Applications should be addressed to Craig Carpenter at cwcarp@msu.edu and must include:

- 1. Student's name, university, department, address and contact information.
- 2. Title of the extension program to be delivered.
- 3. A summary of the proposed extension program. This should include project outcomes, target audience, delivery plans, communication methods and activities planned for distributing the information to the public such as fact sheets, reports, web sites, spreadsheets, and presentations (4 page maximum). If the applicant was part of a team, the role of the applicant within the team must be made clear. If the proposed project is building upon the success of other extension programs, the summary should include a description of the previous program and the innovative approach of this proposed project.
- 4. An educational popular press article limited to 500 words and no more than two graphics (tables, charts, etc.). This should be an addendum to your submission packet. Examples include: https://farmdocdaily.illinois.edu/2023/01/us-price-inflation-focus-on-farm- prices.html and https://southernagtoday.org
- 5. A detailed evaluation plan. This should be an addendum to your submission packet. You may choose to develop your project using a logic model (which is not required). You can see more information on logic models below.*
- 6. A profile of the applicant's background and research (1 page maximum).
- 7. The mentor's name and description of the mentor's role in the project.

Finalists at AAEA

Finalists will be selected to make a 15-minute presentation at the AAEA meeting in Denver, CO on Sunday July 27, 2025, to a panel of judges, who will then ask 5 minutes of questions. The competition will begin at 8AM MDT. Selection of the finalists will be based on the material submitted and the criteria listed above. Finalists will be notified by June 6, 2025. The top three finalists are expected to make presentations during an AAEA Extension track organized symposium if present in Denver, CO. Date and time during conference to be determined.

Awards

Cash awards will be given to those judged to be the top three graduate students in this competition. Award funding is provided by the AAEA Extension Section through membership dues and via support provided by sponsors. Awards are:

First Place: \$1,000 and a plaqueSecond Place: \$300 and a certificate

Third Place: \$200 and a certificate

• Other finalists receive finalist certificates.

The top 3 competitors selected will be recognized at the AAEA Awards ceremony. All finalists will be provided tickets to the Extension Luncheon during the AAEA annual meetings.

Call for submissions: AAEA invited paper sessions at the 2026 ASSA Annual Meeting

President-Elect Brian Roe is soliciting proposals and suggestions for AAEA invited paper sessions at the 2026 Allied Social Sciences Association (ASSA) Annual Meeting in Philadelphia, PA, January 3-5, 2026.

The objective of AAEA sessions at the ASSA Annual Meeting is to share new knowledge of interest to economists. The AAEA encourages sessions that will draw widely from ASSA attendees, including sessions jointly sponsored with other ASSA member associations.

A subcommittee of the AAEA Board will review all proposals. Preference will be given to proposals that

- 1. Cover issues of national and international importance,
- 2. Expand capabilities and tools for economic research,
- 3. Promise a high-quality collection of papers suitable for publication.

Papers in approved Invited Paper sessions are eligible to be peer reviewed for publication in the proceedings issue of the *Applied Economic Perspectives and Policies*. Authors will be contacted by the *AEPP* editors with manuscript submission details.

Proposed formats for the 2-hour sessions may include either three papers with one discussant or else four papers with no discussant. All proposals must include a plan for fostering participant interaction.

Proposals should include the session title and paper titles, as well as the names, addresses, phone numbers, and e-mail addresses of the session organizer, moderator, paper presenters, and discussants. Proposal text should begin with a short justification of the session, followed by one paragraph abstracts describing the objective and contributions of each paper. The organizer is responsible for ensuring that all individuals identified in the proposal are willing to participate.

All speakers and discussants must be members of AAEA, although the proposal may request a membership waiver under special circumstances. Participants must register for the ASSA meeting.



Kim graduated from J. W. Riley High School, South Bend, Indiana, in 1969, and attended Purdue University, obtaining a bachelor's degree in Forestry in 1973. He completed advanced studies in Forest Genetics, before obtaining an MBA degree from Indiana Wesleyan University. Additionally, he independently studied computer science, and utilized those self-taught skills extensively in his various jobs.

Kim first worked at Purdue University part-time in the library as an undergraduate. Following graduation, he spent his entire professional career at Purdue until his retirement in 2018 from his position as Senior Public Policy Analyst in the Agricultural Economics Department. In 2017 he was recognized by the Agricultural Economics Department for outstanding administrative professional service.

Kim was a beloved presence on campus where he also taught several classes, and served as an academic counselor for scores of students over the years, many of whom fondly called him "Uncle Kim."

After playing undergraduate intramural volleyball, he began serving the University years later as broadcaster for Purdue Women's Volleyball, calling the action at home, and traveling with the team to stream play by play broadcasts on Purdue Radio at all away games. In 1988 he was selected to travel to the Seoul, South Korea Summer Olympics to produce stats to be fed to NBC TV anchors for the US Women's Olympic Volleyball competition. He had previously done the same for ESPN when Purdue hosted the NCAA Volleyball Final Four Tournament the year before. In his long broadcasting career, he set a record among US Women's College Volleyball broadcasters for the number of games broadcast without missing a match.

Kim cultivated expertise in a wide range of interests, becoming an avid golfer, a talented wildlife and nature photographer (also photographing weddings for friends and family), an accomplished singer, bass guitar player and songwriter, forming Cloudburst and then Windborne Gospel Group with friends Kirk Janowiak and Jeff Grinstead. They performed throughout the Midwest for over ten years. He also was a skilled woodworker, specializing in marquetry, learned home-building, and was setting up equipment to do blacksmithing at home prior to the advance of his Parkinson's Disease, which rendered him unable to continue pursuing his passions. Known for his ready smile, sense of humor, stubborn independence, generosity, and love and support to friends and family, he received in equal measure love and support from friends and family, especially as his abilities continued to decline and he faced cancer in his final years. He will be greatly missed.

Members Invited to Participate in Federal Statistics Survey

The National Academies' Committee on National Statistics is seeking input from AAEA Members about their use of federal statistics on behalf of a project co-sponsored by the American Statistical Association and George Mason University.

The goal of the <u>Project on the Health of the Principal Federal Statistical Agencies</u> is to independently document the value of the federal statistics and proactively identify challenges and opportunities facing statistical agencies in reports and outreach efforts to Congress, OMB, and other stakeholders. Since federal statistics are intended to be used, input from data users is critical for achieving their goal. They are funded by the Alfred P. Sloan Foundation, Annie E. Casey Foundation, and California Community Foundation.

Providing input is totally voluntary and can take as little or as much time as the respondent wants to devote to it. The project needs to hear from users by February 28 about the strengths and weaknesses of federal statistics. To participate in this optional survey or to learn more,
